



**MACP PPM RPM  
联合声明  
共同解散 MRM  
重新个别收版税**

2020 年 7 月 10 日，吉隆坡 - 大马音乐人版权保护协会 (MACP Berhad 简称 MACP)，大马唱片业公播版权有限公司 (PPM Sdn Bhd 简称 PPM) 和大马唱片艺人协会 (RPM Bhd 简称 RPM) 三家获得政府授权收取公播版税的机构，今天共同宣布解散马来西亚音乐版权公司 MRM Berhad (简称 MRM)。

MRM 是在马来西亚知识产权机构(MyIPO)的指示下，由上述 3 家公播版权特许机构共同成立的一家非盈利合资公司，自 2017 年 1 月 1 日起执行集体音乐授权。

遗憾的是，MRM 因为 3 家特许机构之间在营运方针上无法达成共识，而不能有效地发挥集体授权的作用；这导致了 MRM 无法前进。经过长时间的协商与谈判，3 家特许机构最终决定解散 MRM，而回复像以前一样的个别独立地授权音乐用户。有了这项新安排，音乐用户可以期待三家特许机构提供更高水平的服务。

随着这次的解散，MRM 将终止其业务，并将其授权任务还回给各特许机构。这一决定已照会了 MyIPO 及国内贸易和消费人事务部。




有鉴于此，所有音乐用户与 MRM 已经签订的现有授权合约将被终止，各特许机构将根据各自会员的授权，与用户重新签署授权合约。这项新授权的开始日期为 2020 年 5 月 1 日。

在新的授权安排下，各特许机构将自行制订收费标准，委派友善的授权人员和代理亲自前往会见公播音乐用户和市民，进一步解释新的授权安排。



3 家特许机构将在相关法律及条规的规范下，确保这项新安排顺利进行。
